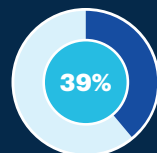

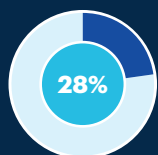

CAPTIVE OWNER

- Primary duties include being a risk manager or captive owner of captive company or risk retention group
- Intended for direct employee of captive's parent/affiliate company
- Primary functions include operating/managing captive (not applicable for board members of a captive)

CAPTIVE MANAGER

- Primary duties include administering/managing captive company or risk retention group on behalf of captive owner
- Must be domicile approved as a captive manager for captives or risk retention groups in at least one state or jurisdiction

SERVICE PROVIDER

- Provide business services to captives, risk retention groups, or the designated representative of an owner
- This category often includes banking, investment, legal, brokerage, carriers, actuarial, TPA's, accounting, tax and others that service the captive industry who are not a domicile-approved captive manager

ACADEMIC

- Employed full-time at academic institution
- Rate intended for deans, professors, or other teaching professionals
- Part-time academia not eligible for this rate
